STUDENT BEHAVIOUR	SCHOOL ACTION	LEVEL	HOW TO RETURN TO BASE LEVEL 0
Student respects the rights of self and others. Is co-operative and self-controlled.	Positively reinforce behaviour with appropriate comments and specific feedback (acknowledgement, sharing success, giving responsibility, etc) Win Bin Tickets at recess and lunch. End of Term activity.	Level 0	
Basically respects the rights of others but has committed <b>minor disruption/offence</b> , e.g. Three warnings, rudeness and annoying others, punctuality a problem, not following school procedures.	Teachers seek solution to problem with students. Students to receive warning or counselling or quiet/calming down time in playground or minor helpful activities whilst thinking about their behaviour. Some students isolated at recess and lunch when necessary.	Level 0	
Persistently violates the rights of others in a minor way. Has continuing but minor offences, e.g. violates rights of others, inappropriate language and behaviour, swearing and inappropriate behaviour during Time Out and Peer Support Program.	Parents informed – note home Documentation recorded on Sentral. Student receives 1 Time Out.  All students on this level or below are entitled to participate in an end of Term activity.	Level 1	Once Time Out is completed and note returned, students return to Level 0.
Continual rudeness and unresponsive in class. Insolence, misbehaving for scripture teachers, casual teachers or parent helpers. <b>Breaches the rights of others.</b> Serious infringements of the rights of others, eg, verbal or physical assault, intimidation, bullying, vandalism, defiance, disruption, etc. Isolated serious breaking of rules, continued deterioration in behaviour and ignoring any attempts to help.	Teacher consults with colleagues and/or support staff. Parents informed by formal letter home or by telephone. In serious cases parents may be contacted and asked to take student home. Documentation recorded on Sentral. Students will be banned from school functions, including Year 6 Farewell. Deprived of all privileges including representing the school in any area until they return to Level 1. May only play under covered area for 2 weeks while sitting at tables.	Level 2	Behaviour is monitored for those two weeks. Student fulfils Time Out obligations. To return to Level One no time out received for two weeks.

Seriously violates the rights of others and shows no signs of wanting to change, e.g. abusive, poor affect on peers, dangerous, uncontrollable and uncooperative.	Teacher refers problem directly to Principal. Cautionary letter of suspension sent home with recommendation for the parents/ carers to meet to discuss the issues or same restrictions as Level 2. Students may also be suspended. Documentation filed.	Level 3	Behaviour is monitored for those two weeks. No new time outs for two weeks.
Continues behavior or commits offence outlined in Department of Education and Training's "Procedures for the Suspension and Expulsion of School students" document. e.g:- * Is in possession of a suspected illegal substance. * Is violent or threatens serious physical violence. *Is in possession of a prohibited weapon. *Is persistently disobedient. * Engages in criminal behaviour related to the school. This includes bringing alcohol and cigarettes to school.	Suspension action taken is to be consistent with the procedures of the Department of Education and Training's "Procedures for Suspensions ..." document and this school's Discipline Code. May be short term, ie, up to and including 4 days out of school, or long term, ie, up to and including 20 school days.	<b>Suspension</b>	On return to school will be placed on Level 3 – may only play under the covered area for 2 weeks while sitting at the tables. Next two weeks may only play under covered area or top playground.
Behaviour outlined in: Department of School Education and Training's "Procedures for Suspension and Expulsion of School Students".	Expulsion action taken consistent with procedures outlined in Department of Education and Training's "Procedure for ... Expulsions ..." documents.	Expulsion	

\* If a student is placed on any Level, that student must work their way back through ALL Levels below theirs.

\* If a student is on Level 2 or 3 and commits any Grade offence, their two week period to return to the Level below starts again from that date.

\* Level 2 & 3 students play at the tables under covered area and/or fulfill Time Out obligations.

\* Students on time out will play under COLA until Time Out begins.

If the school has concerns on safety grounds for a student's attendance on an excursion the school will contact the parents so that a suitable arrangement can be made.
